Meeting Kiosks

Meeting Kiosks are a turnkey display option, allowing firms to have a dedicated, branded space to use for meetings during the conference. Kiosks are beneficial for firms who set up meetings in advance or during the conference. Kiosks do not require staffing, allowing your company's representatives to network, attend sessions, and frequent the kiosk as needed for meetings and demos.

Kiosk Pricing

Kiosks are open to member and non-member firms.

Members: \$3,750 Non-Members: \$4,250




