2020 NMHC Sponsorship Terms & Guidelines:

The Sponsor agrees to comply with the following terms:

Sponsorship Agreement: It is understood that by submitting this application for sponsorship, your company and its representatives agree to abide by the rules and regulations as outlined in the Sponsor Terms & Guidelines. This form, when submitted and accepted by the National Multifamily Housing Council, becomes a contract.

Payment: Payment is due on or before January 3, 2020 for Chairman's Circle, Friends of the Council, and 2020 NMHC Annual Meeting and 2020 NMHC Apartment Strategies Individual Meeting sponsorships. All other meeting/conference sponsorships must be locked in and fully paid a minimum of 45 days prior to the meeting. Credit card payments and checks are accepted.
