# **Surge in College Applications Unaffected by the Economic Downturn**

- Reinforcing the "recession-resistant" nature of student housing, this analysis of 56 universities shows an average growth rate of 20 percent for freshman applications for the fall of 2010 compared to fall 2008.
- Twenty-three of the schools surveyed reported a gain of 25 percent or more; only four schools showed a decrease in enrollment.
- This white paper reviews the results of our survey and offers cautionary advice to firms considering entering the private, off-campus student housing industry.

### **Surge in College Applications Unaffected by the Economic Downturn**

There have been numerous reports about the "recession-resistant" nature of student housing. The National Student Housing Council (NSHC), a subsidiary of the National Multi Housing Council (NMHC), analyzed enrollment trends at 56 universities to see if the economic downturn had caused a decrease in enrollment.

Of course, a recession and the resulting unemployment it creates can drive an increase in college enrollment, but conventional wisdom holds that many of those new students would apply to community colleges instead of traditional four-year universities for cost reasons. Going into the most recent economic downturn, there was concern that families struggling with falling house prices and possible unemployment would defer their children's education until they were more confident about the overall economy.

Our research indicates that those concerns were unfounded. We compared the number of freshman applications at 56 universities across the country (public and private) for fall 2010 and fall 2008. Overall, freshman applications were up 20 percent. Twenty-three of the schools reported a gain in the number of freshman applications of 25 percent or more; only four of the universities surveyed showed a drop in freshman applications.

The highest growth was recorded by the University of Alabama at Tuscaloosa, which reported a 56% increase.

This study suggests that the pursuit of higher education was not a collateral victim of the financial crisis and resulting economic crisis. Strong demographics, primarily the 78 million echo boomers reaching college age, continue to drive college enrollment and may be helped by unemployed adults seeking new career opportunities. As just one case study, Stanford University reported a 35 percent increase in freshman applications for 2010. It accepted 2,300 of the 34,200 applicants and ultimately enrolled 1,700 freshmen.

While this is encouraging news for the private, off-campus student housing industry, all firms considering entering the sector should not take entry lightly given the unique, and often demanding, requirements for success in this niche. Motivated by the positive coverage of student housing, too many firms have jumped into the sector without fully analyzing actual individual markets. This has led to serious overbuilding at some campuses. It is the goal of NMHC's National Student Housing Council to create a venue for the meaningful exchange of information and ideas among student housing providers so more informed decisions can be made in terms of financing, developing and managing of student housing.
