CDC MOVES FORWARD WITH NEW EVICTION MORATORIUM

NMHC continues to push back on the new eviction moratorium while also creating new resources to help members comply where applicable.

At the urging of the Biden Administration, the Centers for Disease Control (CDC) issued a new eviction moratorium through October 3 for areas of the country with high or substantial rates of COVID infection. The new order is estimated to currently include 80 percent of counties and 90% of the renter population, according to officials.

Leading up to this latest action, NMHC has advocated nonstop to Congress and the Administration that this unsustainable measure must come to an end. In an NMHC statement issued the evening of the announcement, NMHC made clear that this moratorium is completely unacceptable, legally questionable and continues to put an unfair economic burden on millions of housing providers. We, again, underscored these points via an NMHC-led real estate industry coalition statement released the following evening.

Even the President himself acknowledged this legal issue during a press briefing this week. "But, at a minimum, by the time [the new moratorium] gets litigated, it will probably give some additional time while we're getting that \$45 billion out to people who are, in fact,

behind in the rent and don't have the money," President Biden said. And although its legality remains in question, housing providers must still comply where applicable. To that end, NMHC has created a

new resource that outlines key facts housing providers need to know to comply. This resource may be updated as additional information is revealed and NMHC will continue to communicate new information as it's made available.

FHFA AND FHA EXTEND EVICTION MORATORIUMS ON BORROWERS OF FORECLOSED **PROPERTIES**

On July 30, the Federal Housing Finance Agency (FHFA) and the Federal Housing Administration (FHA) announced they would each extend their eviction moratoriums on borrowers of foreclosed properties, which were set to expire on July 31. On the same day, FHFA also issued a press release encouraging landlords of Enterprise-backed properties to apply for emergency rental assistance before moving forward with the eviction process.


