ELSA MARKS THE START OF HURRICANE SEASON: ARE YOUR **ONSITE TEAMS READY?**

As Tropical Storm Elsa barrels through Florida and the southeast, now is the best time for multifamily property owners to take serious stock of their strategies for preparing and dealing with hurricanes.

The 2020 hurricane season saw record breaking activity, and 2021 isn't likely to offer much reprieve. Elsa was initially predicted to hit U.S. land as a Category 1 hurricane, but by the time it made it to shore it was downgraded to a tropical storm. However, as it travels through Florida, Georgia and the Carolinas it's still predicted to leave behind considerable destruction and flooding.

And although this marks one of the first major storms of the season, it certainly won't be the last. NOAA predicts this season could see 13 to 20 named storms, of which six to 10 could become hurricanes, including three to five major hurricanes. Luckily, it's not too late to begin implementing preparedness measures.





According to recent data from RealPage, apartment demand has hit unprecedented levels. The number of occupied apartments in the 150 biggest U.S. metros increased by 219,909 units in the second quarter. This marks the largest quarterly increase since the 1990s.


Higher rents are the kind of price increase that's hard to reverse—unlike many of the ones that have
