

SENATORS SEEK TO REFORM SECTION 8 PROGRAM WITH NMHC-SUPPORTED CHOICE IN AFFORDABLE HOUSING ACT

The <u>Choice in Affordable Housing Act</u> was introduced in the Senate last week with bipartisan support and backing from both housing advocates and housing providers—including NMHC. If enacted, this legislation would invest \$500 million in the Housing Choice Voucher (HCV) program to help break down barriers for housing provider participation and, therefore, increase participation in "high-opportunity neighborhoods." NMHC has long argued that, if reformed, the Section 8 HCV program could be the nation's most effective affordable housing and community development tool.



SENATE REPUBLICANS OFFER NEARLY \$1T INFRASTRUCTURE COUNTERPROPOSAL

On Thursday, May 27, Senate Republicans signaled they would be willing to support \$1 trillion in infrastructure spending, the latest counteroffer to President Biden's proposal to rebuild the nation's roads, bridges and transit systems.

Federal officials have ordered Fannie Mae and Freddie Mac to purchase more loans on affordable to moderate-income properties to help ease housing affordability burdens by spurring workforce housing development.

\$3.4 BILLION FCC COVID BROADBAND BENEFIT PROGRAM AVAILABLE TO MULTIFAMILY INDUSTRY

Multifamily owners of properties at which bulk internet service is offered to low-income residents may be eligible to receive relief under the Emergency Broadband Benefit (EBB) Program. Under the EBB program, all qualified low-income households are eligible for a \$50.00 per month discount to their monthly Internet access service (\$75.00 per month for qualified households on Tribal Lands) and a one-time reimbursement of \$100 for a laptop, desktop or tablet.
