# NMHC LEADS REAL ESTATE COALITION EFFORT TO PROMOTE HOUSING AS INFRASTRUCTURE AND GUARD AGAINST HARMFUL **REVENUE-RAISING PROPOSALS**

With the Biden Administration and Congress focused on the possibility of enacting legislation to address the nation's infrastructure needs, Congressional committees convened this week to discuss potential inclusions and how such measures might be financed. In connection with hearings held by the House Ways and Means, Senate Finance and Senate Banking Committees, NMHC weighed in to underscore the importance of including housing provisions, while also warning against enacting tax pay-fors that would erode job creation and hinder economic growth.

Policymakers have a historic opportunity to make a once-in-a-generation investment in our nation's infrastructure, which is why NMHC continues to stress the undeniable link between housing and infrastructure. However, we are also concerned that the proposed pay-fors could undermine the very infrastructure goals the Administration seeks to achieve by: reducing opportunities and economic rewards for cash-poor business owners; hindering real estate investment, particularly in affordable housing; and undercutting the tax base in localities that rely on these taxes to finance schools, police, and other first responders.



#### NMHC WEIGHS IN AS FLOOD DEBATE RESUMES ON CAPITOL HILL

With the National Flood Insurance Program (NFIP) operating on yet another short-term authorization that runs until September 30, 2021, Congress has begun work in trying to reauthorize and reform the program on a long-term basis. In recent weeks, committees in both the House and Senate have explored the topic. And this week, NMHC submitted a letter to the Senate Banking Committee as it convened a hearing to discuss a range of issues posing operational and financial challenges to the longterm viability of the NFIP and its continued affordability. In addition to calling on Congress to provide for a long-term reauthorization of the NFIP, NMHC called on lawmakers to enact a number of reforms to improve the multifamily and commercial lines of the NFIP to better mitigate the financial risk of flooding




