Provisions Tied Up in End of Year Packages

With the House set to return from August recess next week and the Senate returning the week after, NMHC is eyeing a number of potential legislative actions that will have a direct impact on the multifamily sector—including the extension of the NFIP, the fate of HUD's FY23 budget, the reauthorization of the military housing budget and changes to key housing development tax provisions.

Conversation Highlights: In her discussion with fellow panelists, Walter remarked on the persisting supply-demand imbalance by citing <u>recent</u> <u>research</u> that indicates the need to build 4.3 million more apartments by 2035 to keep up with national demand.
