SEC CLIMATE PROPOSAL WOULD INCREASE COSTS, LOWER RETURNS

As previously reported, the SEC is moving to require publicly traded companies to make certain climate-related disclosures.

If made final as is... the proposal would increase multifamily operating costs, resulting in higher prices, fewer affordable housing options for renters and lower returns for investors.

What We're Doing About It: NMHC weighed in with the SEC this week to push back on unreasonable and outright unworkable provisions that would require firms to significantly alter their business operations. We offered five alternative provisions in place of the nonstarters.
