

THIS JUST IN: NMHC SURVEY REVEALS RISING INTEREST RATES ARE LEADING TO GREATER CONCERN ABOUT COST OF CAPITAL

Yesterday's <u>release</u> of NMHC's most recent <u>Quarterly Survey of Apartment Market Conditions</u> revealed that apartment markets tightened further for April 2022, while financing became more costly. This is the third consecutive quarter that debt financing has become less available but the first time in six quarters that the survey indicated that equity financing become less available. <u>Click through for the full data dive.</u>
