



AS FEDERAL PROVISIONS EXPIRE, SENATE REPUBLICANS RELEASE THEIR COVID-19 RELIEF OPENING OFFER

As key benefits and protections set forth in the CARES Act expire today—most notably the expanded unemployment benefits—the financial distress from the outbreak of COVID-19 continues, affecting apartment renters. NMHC continues to lobby Congress to extend the benefit and complement it with a direct rental assistance program. MMHC has also released a variety of suggestions to support housing stability for apartment firms to consider implementing.

This week, Senate Republicans released a \$1 trillion COVID-19 relief package known as The Healthcare, Economic Assistance, Liability, Act). Although the HEALS Act fails to provide funds for an emergency rental assistance program and seriously lessens the extended unemployment benefits, it does address other industry priorities, such as liability protections. Also notably, the package doesn't include an extension of the CARES Act federal eviction moratorium. The release of this legislation comes two months after House Democrats released their version of a COVID-19 relief package, the \$3 trillion Health and Economic Recovery Omnibus Emergency Solutions Act (HEROES Act). Democrats and Republicans will have to negotiate what will become the final legislation. While the timeline for this next package is unclear, it could take the better part of the next few weeks to reach a deal, with a final package coming together between August 7 and 14.

AFFECTED BY COVID-19

Recognizing that there could be additional disruption for renters and housing providers as federal benefits and protections expire and Congress works on a new relief package, NMHC has released a variety of suggestions to support housing stability for apartment firms to consider implementing and created several new member resources.

The newly released housing stability suggestions are intended to demonstrate effective eviction mitigation strategies, recognizing that an eviction is a painful, expensive process for all involved and is only ever taken as a matter of last resort. To that end, one of the new tools released is an <u>eviction mitigation resource document</u> that offers housing operators an array of suggested techniques to help keep residents housed. The second is a <u>list of renter assistance resources</u> that can help residents facing financial hardships; this list is available online and also in a <u>customizable template</u> for distribution.

NMHC RENT PAYMENT TRACKER FINDS TWO-PERCENTAGE POINT DECREASE IN RENT PAYMENTS

NMHC's Rent Payment Tracker found 93.3 percent of apartment households made a full or partial rent payment July 1-27. This is a 2.0-percentage point decrease from the same period a year ago and compares to 94.7 percent that had paid by June 27, 2020.
