RENTAL ASSISTANCE FAQ

This week, the <u>U.S. Treasury published a Frequently Asked</u> Questions (FAQ) regarding the \$25 billion Emergency Rental Assistance Program (ERAP) approved in the COVID-19 relief package that was signed into law on December 27. The guidance in this document supersedes the initial Treasury FAQ released on January 19. Prior to the release of the most recent FAQ, NMHC led a real estate stakeholder coalition letter asking for clarification and guidance on a number of key issues and are pleased Treasury incorporated several industry

recommendations into the updated FAQ. NMHC has compiled information included in the Treasury Department's FAQs into an easily navigable webpage to help housing providers navigate this ever-changing landscape. NMHC will continue to communicate with the Treasury on changes and additional clarifications that should be made to ensure the program can be executed in an efficient and timely manner.

TEXAS COURT RULES CDC EVICTION ORDER EXCEEDS FEDERAL AUTHORITY



Yesterday, a Texas Court ruled that the CDC Order to Temporarily Halt Evictions exceeds federal authority. The ruling is based solely on the question of whether the moratorium violated constitutional limitations and falls outside the federal government's power to regulate interstate commerce. Because the implications of this order are limited, apartment providers should continue to consult with their counsel about how best to proceed on matters relating to evictions.

HOUSE PASSES NMHC-SUPPORTED EQUALITY ACT


This week, the U.S. House of Representatives passed the NMHC-supported Equality Act. This legislation bans discrimination based on gender identity and sexual orientation. Prior to the House passage, NMHC joined a broad coalition of business groups in sending a letter of support to House leadership. "Equality of opportunity is a key pillar of our great democracy—one that allows all people to pursue their American Dream—and part of what makes our nation exceptional," the letter reads. "Our industries, representing and employing tens of millions of Americans, understand this basic fact and have been at the forefront of efforts to combat discrimination based on sexual orientation and gender identity in housing, and in the workplace."



MANY PEOPLE ARE BEHIND ON RENT. HOW MUCH DO THEY OWE? There is no comprehensive way to track rental payments, and it is difficult to know how much back rent is owed because high-quality data are unavailable. Thus, estimates of back rent owed by early 2021 range from \$8.4 billion to \$52.6 billion. A range this large can be confusing and lead to a lack of action.




